1 Introduction

This document describes the level of support provided by Microsoft web browsers for the *Cross-Origin Resource Sharing* [CORS] specification, published 16 January 2014. The [CORS] specification defines a mechanism to enable client-side cross-origin requests. It is a building block for other specifications, so-called CORS API specifications, which define how the [CORS] specification is used.

This document describes support for aspects of [CORS] pertinent to XMLHttpRequest [XMLHTTPR-LEVEL1], an implementation of [CORS] for Windows Internet Explorer 8 and Windows Internet Explorer 9.

1.1 Glossary

MAY, SHOULD, MUST, SHOULD NOT, MUST NOT: These terms (in all caps) are used as defined in [RFC2119]. All statements of optional behavior use either MAY, SHOULD, or SHOULD NOT.

1.2 References

IE10 Mode and IE11 Mode (all versions)

Origin lists are not supported. Instead, a single origin and the "null" string is supported.

2.1.2 [CORS], Section 7.1.7, Generic Cross-Origin Request Algorithms

V0002:

The specification states:

Whenever the make a request steps are applied, fetch the request URL from origin source origin using referrer source as override referrer source with the manual redirect flag set, and the block cookies flag set if the omit credentials flag is set.

IE10 Mode (all versions)

The override referrer source is not supported.
