V####	Identifies an intended point of variability in the target specification such as the use of MAY, SHOULD or RECOMMENDED. (See <a href="[RFC2119]">[RFC2119]</a> .) This does not include extensibility points.	
E####	Identifies extensibility points (such as optional implementation-specific data) in the target specification, which can impair interoperability.

### **2 Standards Support Statements**

V0001:

The specification states that the media features width, height, device-width, device-height, color, color-index, and monochrome should be ignored if the value is negative.

IE9 Mode, IE10 Mode, IE11 Mode, and EdgeHTML Mode (All Versions)

Values greater than -0.001 but less than 0 are rounded to zero and treated as valid and not ignored.
