V####	Identifies an intended point of variability in the target specification such as the use of MAY, SHOULD, or RECOMMENDED. (See [RFC2119].) This does not include extensibility points.		
E####	Identifies extensibility points (such as optional implementation-specific data) in the target specification, which can impair interoperability.

2.1.1 [W3C-CSS3-MediaQueries] 4. Media features

V0001:

The specification states that the media features width, height, device-width, device-height, color, color-index, and monochrome should be ignored if the value is negative.

IE9 Mode, IE10 Mode, IE11 Mode, and EdgeHTML Mode (All Versions)

Values greater than -0.001 but less than 0 are rounded to zero and treated as valid and not ignored.

2.2 Clarifications

There are no clarifications of the MAY and SHOULD requirements of [W3C-CSS3-MediaQueries].

2.3 Error Handling

There are no additional error handling considerations.

2.4 Security

There are no additional security considerations.
