# 1 Introduction

This document describes the level of support provided by Microsoft web browsers for the W3C HTML5 Image Description Extension (longdesc) specification [\[W3C-LONGDESC\]](#), published 26 February 2015. The [W3C-LONGDESC] specification defines a longdesc attribute (based on the longdesc attribute of HTML 4) to link descriptions to images in HTML5 content.

Each browser version may implement multiple document rendering modes. The modes vary from one to another in support of the standard. The following table lists the document modes supported by each browser version.

For each variation presented in this document there is a list of the document modes and browser versions that exhibit the behavior described by the variation. For example, the following list for a variation indicates that the variation exists in three document modes in all browser versions that support these modes:

*Quirks Mode, IE7 Mode, and IE8 Mode (All Versions)*

V####	This identifies an intended point of variability in the target specification such as the use of MAY, SHOULD, or RECOMMENDED. (See <a href="#">RFC2119</a> .) This does not include extensibility points.
E####	Because the use of extensibility points (such as optional implementation-specific data) can impair interoperability, this profile identifies such points in the target specification.
