1 Introduction

This document describes the level of support provided by Microsoft web browsers for the W3C HTML5 Image Description Extension (longdesc) specification [\[W3C-LONGDESC\]](#), published 26 February 2015. The [W3C-LONGDESC] specification defines a longdesc attribute (based on the longdesc attribute of HTML 4) to link descriptions to images in HTML5 content.

MAY, SHOULD, MUST, SHOULD NOT, MUST NOT: These terms (in all caps) are used as defined in [\[RFC2119\]](#). All statements of optional behavior use either MAY, SHOULD, or SHOULD NOT.

E####	Because the use of extensibility points (such as optional implementation-specific data) can impair interoperability, this profile identifies such points in the target specification.
