This documented describes the level of supported provided by Microsoft web browsers for the W3C HTML5 Image Description Extension (longdesc) specification [W3C-LONGDESC], published 26 February 2015. The [W3C-LONGDESC] specification defines a longdesc attribute (based on the longdesc attribute of HTML 4) to link descriptions to images in HTML5 content.
